EXCEPTIONS TO APPLICATION AND RULES  
APPLIES ON CARS OTHER THAN TANK CARS**

**▲ ITEM 542-B**

**NORFOLK SOUTHERN RAILWAY COMPANY**

1. The provisions of item 615 Series, or other provisions for the movement of empty freight cars, other than tank cars, will not apply to such cars moving to, from, or via Norfolk Southern Railway Company unless the empty movement is immediately preceded by a revenue move on the Norfolk Southern Railway Company then the following empty move is free.
2. On back to back empty moves, the second move is chargeable and rates can be obtained in NSRQ 4900 Series item 101030 series.
3. If an empty car is received at interchange from a connecting carrier the car will move free of charge if the car's next move is a revenue line-haul movement via the Norfolk Southern Railway Company.

**EXCEPTION**

1. All new restencilled cars moving on their own wheels, except tank cars from car manufacturer(s) (builder(s)) or repair shops to cars owner or customer will be subject to charges published in tariff NSRQ 4900 Series. For tank cars on their own wheels provisions in Section 1 of item 190 Series will apply.
